This waiver of liability goes to any intentional or negligent act that may be performed by the operator of a public or private display, owner of the land in which the fireworks are to be used, or **Northern Lights Pyros Club** member(s).

The registrant undersigned, and individuals listed below, agree to abide by all safety rules and conduct guidelines.
